<p><b>To ensure that 100% of pupils who receive pupil premium funding pass the phonics screening check in Year One and the catch-up check in Year 2 (86%).</b>  <u>Rationale:</u> To ensure that there is no difference between children receiving the pupil premium funding and others in regards to early reading and that pupils have the necessary knowledge and skills to be fluent and confident readers.</p>	
<p><u>Success Criteria:</u>            In Year One, 100% OF children who receive pupil funding pass the phonics screening check in June 2021.            In Year Two, children who receive pupil funding pass the catch-up phonics screening check in December 2020.</p>

<p><u>Success Criteria:</u> The majority of children receiving the pupil premium funding (80%) leave Year Four and Five At the expected standard with a proportion of pupils working at Greater Depth.</p>

<p><b>To provide children who receive pupil premium funding with support to participate in additional opportunities to enrich their curriculum. Due to Covid 19, we are hoping that we can fulfil this objective from January 2021. In the interim, we are supporting our pupils with opportunities within the school day.</b></p> <p>Rationale: That all children have the same opportunities and are able to access all opportunities provided by the school both internally and externally.</p>	
<p><u>Success Criteria:</u> All children who receive pupil premium funding have the opportunity to attend additional enrichment activities.</p>	
<p>Actions</p> <ul style="list-style-type: none"> <li>• Monitor participation of pupil children in all enrichment activities on offer.</li> <li>• Support families with the cost of external clubs or visitors.</li> <li>• Support families with uniform costs.</li> <li>• Provide funding to cover the costs of school trips.</li> </ul>	<p>Actions</p> <ul style="list-style-type: none"> <li>• Families are able to support club participation around busy family life.</li> </ul>
<p><b>To ensure that the attendance of children who receive the pupil premium funding is in line with their peers.</b></p> <p>Rationale: Children who receive the funding are not at a disadvantage due to their school attendance.</p>	
<p><u>Success Criteria:</u> The attendance of all children who receive pupil premium funding is 95% of above and in line with their peers.</p>
